The University of Hyderabad has launched an ambitious plan to leverage Category I Graded Autonomy (GA) conferred by UGC vide UGC Gazette Notification dt. 12/02/2018 on [Categorisation of Universities (only) for grant of Graded Autonomy] Regulations, 2018. Subsequently the Institute of Eminence (IoE) conferred upon to the University by the MHRD vide MHRD Notification No. F.11/9/2019-U3(A) dt: 17/2/2020 to take the University to the next level of academic excellence. Under the GA/IoE plan, a few new positions are created viz. IoE Distinguished Professor (**IoE-DP**), IoE Research Professor (**IoE-RP**), IoE Fast Track Research Associate Professor (**IoE-RAOP**) and IoE Research Assistant Professor (**IoE-RAIP**), **Three** numbers at each level under Project mode as below:

- To provide impetus for research activity across the borders of traditional disciplines, and to play a leading part in academic, social and research debates with sustained contributions to the growth and visibility of the University and
- to encourage and recognize contributions of young faculty, fast track promotion is created under GA/IoE from Assistant Professor to Fast Track Research Associate Professor.

This announcement is part of selecting internal and eligible faculty to focus more on IoE objectives. A few more such initiatives will be announced later to induct few more faculty for better contributions to the IoE project.

All the incumbents (internal faculty) appointed under this project will be drawing their salaries from their substantial posts in the university and the differential amounts (research grant and additional special allowance, difference in pay etc.) will be met from the IOE project/GA provisions.

The Schools are divided in to two Groups – viz :

- Group-A:** School of Physics, School of Chemistry, School of Mathematics & Statistics, School of Computer & Information Sciences, School of Medical Sciences, School of Engineering Sciences & Technology, School of Life Sciences
- Group-B:** School of Humanities, School of Social Sciences, School of Management Studies, Sarojini Naidu School of Arts & Communication and School of Economics

1. IoE Distinguished Professor – Up to 3 positions (not more than one in the same School):

Initial appointment is for a period of three years under project mode, extendable every three years, till the incumbent attains the age of 70 years. Faculty members with 10 years of experience as Professor, with greater global visibility for their research contributions in respective discipline, as judged by the peers in the field and/or respective academies, evidenced by high quality publications will be considered.

1.1. Eligibility:

- i) Faculty members having at least 10 years of experience as Professor.
- ii) A minimum of 30 publications in high-quality, globally indexed or UGC-CARE listed journals in the immediate past 10 years. For Group-B Schools the publications includes Books and Book Chapters.
- iii) A minimum score of 85 points (for Group-A Schools) and 75 (for Group-B Schools) as assessed from the data sheet devised for the purpose.

1.2. Selection:

The assessment period for the evaluation shall be 10 years preceding to the last date of the notification. Evaluation shall be done by a team of experts constituted for the purpose, which shall consider the Eligibility criteria duly weighted together with

- i) the quality of distinctions, honours and awards received,
- ii) Papers in high impact journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books/book chapters from publishers with established peer-review process, Citations, Impact Factor, peer reviewed conference proceedings, art work/production. For Group-B Schools 50% of the total publications should be in Journals.
- iii) Keynote/Plenary addresses delivered in high quality conferences,
- iv) Ph.D. guidance, mentoring of post-doctoral fellows,
- v) serving on the editorial board of reputed journals,
- vi) external grants received for research, Innovations made etc.

1.3. Conditions of Appointment:

- i) Entitled for Rs 12,00,000/year research grant, Additional Special Allowance of Rs. 35,000 per month.
- ii) Review of contributions for every 3 years, and submission of annual reports will be mandatory.
- iii) Allowed to have limited teaching and will have the option to decide her/his courses and specify numbers.

1.4. Expectations:

- i) Delivering special lectures.
- ii) One-to-one advice on particular pieces of work.
- iii) Course design, Lecture / seminar planning.
- iv) Should publish papers in high quality journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current

- Contents/UGC-CARE] or books from publishers with established peer-review process.
- v) Services of IoE-DP may be called upon for Innovation and Mentoring plans in the University.
- vi) IoE-DP may be asked to serve on IQAC, syllabus re-evaluation committees, including IoE related activities etc.
- vii) Help with internationalization by networking with world-renowned universities and eminent scholars.
- viii) Enable and strengthen the research atmosphere and ecosystem in the campus, and their own Schools/Depts by being a role model.

2. IoE Research Professor – Up to 3 positions (not more than one in the same School):

Initial appointment is for a period of three years under project mode, and extendable every three years with other eligible Professors till the incumbent attains the age of 65 years. Highly accomplished Faculty members having at least 5 years of experience as Professor with greater global visibility for their research contributions in respective discipline, as judged by the peers in the field and/or respective academies, evidenced by high quality publications will be considered.

2.1. Eligibility:

- i) Faculty members having at least 5 years of experience as Professor and below 62 years of age.
- ii) A minimum of 25 publications in high-quality, globally indexed or UGC-CARE listed journals in the immediate past 10 years. For Group-B Schools the publications includes Books and Book Chapters.
- iii) A minimum score of 70 for all Schools as assessed from the data sheet devised for the purpose.

2.2. Selection:

The assessment period for the evaluation shall be 10 years preceding to the last date of the notification. Evaluation shall be done by a team of experts constituted for the purpose, which shall consider the Eligibility criteria duly weighted together with

- i) the quality of distinctions, honours and awards received,
- ii) Papers in high impact journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process, Citations, Impact Factor, peer reviewed conference proceedings, art work/production. For Group-B Schools a minimum of 12 publications should be in Journals.
- iii) Keynote/Plenary addresses delivered in high quality conferences,
- iv) Ph.D. guidance, mentoring of post-doctoral fellows,
- v) serving on the editorial board of reputed journals,
- vi) external grants received for research, Innovations made etc.

2.3. Conditions of Appointment:

- i) Entitled for Rs 9,00,000/year research grant.
- ii) Additional Special allowance of Rs. 30,000 per month.
- iii) Allowed to have limited teaching and offer specialized courses. Will be eligible to have Joint/School-level appointments and therefore offer Open Elective Courses.
- iv) Appointments are subject to annual review on the performance through a duly constituted process after submission of annual progress reports.

2.4. Expectations:

- i) Expected to promote the research atmosphere on the University campus.
- ii) The major research activity to be conducted at the University, including IoE related activities.
- iii) Should publish papers in high quality journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process and thereby enhance the research outcomes.
- iv) Help with internationalization by networking with world-renowned universities and eminent scholars.
- v) Enable and strengthen the research atmosphere and ecosystem in the campus, and their own Schools/Depts by being a role model.

3. IoE Fast Track Research Associate Professor – Up to 3 positions (not more than one in the same School)

Appointment is for a period of 3 (three) years under project mode and extendable by another 2 (two) years under project mode.

3.1. Eligibility:

- i) Faculty members having at least 5 years of service as Assistant Professors.
- ii) A minimum of 12 publications in high quality journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process in the immediate past 8 years. For Group-B Schools 50% of the total publications should be in Journals.
- iii) Should have successfully guided at least one Ph.D. student.
- iv) A minimum score of 70 for all Schools as assessed from the data sheet devised for the purpose.

3.2. Selection:

The assessment period for the evaluation shall be 8 years preceding to the last date of the notification. Evaluation shall be done by a team of experts constituted for the purpose, which shall consider the Eligibility criteria duly weighted together with

- i) The quality of distinctions, honours and awards received.
- ii) Papers in high impact journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process Citations, Impact Factor, peer reviewed conference proceedings, art work/production. For Group-B Schools 50% of the total publications should be in Journals.
- iii) Invited/Keynote/Plenary addresses delivered in high quality conferences.
- iv) Ph.D. guidance, mentoring of post-doctoral fellows.
- v) Serving on the editorial board of reputed journals.
- vi) External grants received for research; Innovations made etc.

3.3. Conditions of Appointment:

- i) Entitled Rs 6,00,000/year research grant;
- ii) Eligible to draw the difference in the salary at their current UGC scale for Assistant Professor and UGC scale for Associate Professor as long as he/she is in the position of Research Associate Professor.
- iii) Appointment is tenable only until the faculty member becomes eligible for Associate Professor (Direct/CAS) under UGC regulations.
- iv) The service rendered in the University of Hyderabad will only be taken into account.
- v) Appointments are subject to annual review on the performance through a duly constituted process. Annual progress report is mandatory.
- vi) The incumbent will be eligible for the post of Associate Professor (Direct/ CAS) as and when he/she gets eligibility as per the UGC regulations. He / she should not be eligible to use this service to apply for the Professor promotion (under CAS) during the tenure of Research Associate Professor.

3.4. Expectations:

- i) Expected to promote the research atmosphere on the University campus.
- ii) The major research activity to be conducted at the University, including IoE related activities.
- iii) Should publish papers in high quality journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process and thereby enhance the research outcomes.
- iv) Help with internationalization by networking with world-renowned universities and eminent scholars.
- v) Enable and strengthen the research atmosphere and ecosystem in the campus, and their own Schools/Depts by being a role model.

4. IoE Research Assistant Professor – Up to 3 positions (not more than one in the same School)

Appointment is for a period of 3 (three) years under project mode and extendable by another 2 (two) years under project mode.

4.1. Eligibility:

- i) Faculty members having at least 3 years of service as Assistant Professors in the University of Hyderabad.
- ii) A minimum of 10 publications in high-quality journals [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process. For Group-B Schools 50% of the total publications should be in Journals.
- iii) A minimum score of 70 marks for all Schools as assessed from the data sheet devised for the purpose.

4.2. Selection:

The assessment period for the evaluation shall be 5 years preceding to the last date of the notification. Evaluation shall be done by a team of experts constituted for the purpose, which shall consider the Eligibility criteria duly weighted together with

- i) the quality of distinctions, honours and awards received,
- ii) Papers in high impact journals/ [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process, Citations, Impact Factor, peer reviewed conference proceedings, art work/production. For Group-B Schools 50% of the total publications should be in Journals.
- iii) Keynote/Plenary addresses delivered in high quality conferences,
- iv) serving on the editorial board of reputed journals,
- v) external grants received for research, Innovations made etc.

4.3. Conditions of Appointment:

- i) Entitled for Rs 6,00,000/year research grant;
- ii) Additional Special allowance of Rs. 25,000 per month.
- iii) An Assistant Professor may be recognized and appointed as IoE-RAIP only once during her / his tenure.
- iv) The IoE-RAIP will be considered for less teaching by the academic unit.
- v) Appointments are subject to annual review on the performance through a duly constituted process, and submission of annual progress report is mandatory.

4.4. Expectations:

- i) Expected to promote the research atmosphere on the University campus.
- ii) Be involved with major research activities within the University, including IoE related activities.
- iii) Should publish papers [indexed in Web of Science/SCOPUS/Arts and Humanities Citation Index/ABDC/Current Contents/UGC-CARE] or books from publishers with established peer-review process and thereby enhance the research outcomes.
- iv) Help with internationalization by networking with world-renowned universities and eminent scholars.
- v) Enable and strengthen the research atmosphere and ecosystem in the campus, and their own Schools/Depts by being a role model.

4. The top TWO scorers from every School will be shortlisted for each position (DP/RP/RAOP/RAIP) for further processing and those applicants, who are shortlisted will be requested to send in hard copies of their CVs.
5. The scores will be validated by the IQAC.
6. The Research Steering Committees and/or Governing Body of the IoE will examine the shortlisted applications.
