Sub: One-time opportunity to all eligible teachers for submission of applications for promotion under UGC-CAS as per 2010/16 Regulations –Reg.

- Ref: 1. Resolution of the Special meeting of the Executive Council dated 06/06/2022
2. Vice-Chancellor's orders dated 18-06-2022

The Executive Council of the University in its special meeting held on 6th June, 2022 resolved as follows:

The Council resolved to authorize the Vice-Chancellor to consider the applications of those faculty, who were eligible for promotion but could not apply for CAS –promotion/placement by the due date of 17th July, 2021 for being considered under UGC 2010/16 Regulations due to the then prevailing Covid-19 situation. Such teachers of the University are required to submit a fresh application for CAS placement/promotion under the provisions of the UGC Regulations, 2010/16 on or before 31st July, 2022, along with the supporting documents evidencing deprivation of the opportunity to apply in time due to Covid-19 situation. This is a one-time opportunity extended as a special case, which shall not to be quoted as a precedent in future and is further subject to the acceptance of the UGC. The faculty availing this one time opportunity will be considered for promotion from the date of their application.


In compliance with the above resolution, the faculty who were eligible for promotion by the due date of 17th July, 2021, but could not submit their applications by said date for placement/ promotion under the provisions of UGC-Career Advancement Scheme may submit a fresh application for CAS placement/ promotion under the provisions of the UGC Regulations, 2010/16 to Deputy Registrar, Recruitment Cell ***on or before 31st July, 2022*** subject to the following conditions:

- i. The applications must be accompanied by the supporting documentary evidence of being deprived of an opportunity to apply by the due date of 17th July, 2021 due to Covid-19 situation.
- ii. ***This is a one-time opportunity extended as a special case***, which shall not be quoted as a precedent in future and it is further subject to the acceptance of the UGC.
- iii. ***No application will be accepted after 31/07/2022.***

- iv. The CAS applications submitted in response to this Circular will only be considered and any applications submitted prior to the date of the issuance of the Circular will *not* be considered.
- v. The faculty availing this opportunity *will be considered for promotion from the date of their application.*
