Deadline : 2 July 2021

Please note the following:

1. Read the entire document very carefully before starting to fill-up the forms.
2. This call is for the period **Jan-Dec 2019** and **Jan-Dec 2020** (subject to conditions in point 3 below).
3. Please claim using the **revised criteria below only for those items not claimed previously**. Repeat claims can lead to cancellation of the IPDF claim.
4. Information for Group A Schools are available on pages 3-6 and Group B Schools on pages 7-9.
5. **Do NOT claim for any item for the assessment period starting January 2021**. There will be a separate call later this year.
6. Attach the documentary evidence **OR** active URL of the Journal/book for all claims (first page of each publication, copies of the research grant received).
7. All claims will be verified by IoE office. Unverifiable claims will not be passed.
8. Please contact IoE office if any clarification required.

IPDF: Revised and Amended Guidelines

Preamble

- The Institutions of Excellence (IoE) Programme received by the University will provide funding towards IoE Professional Development Funds (IPDF), as research performance incentives.
- The IPDF to a faculty member, like the existing PDF scheme of the University, will be provided for his/her research and academic contingencies, conference travel, student and technical support-staff salaries, publication charges etc.
- The financial support given through IoE-PDF will be added to the PDF accounts of the faculty and administered through online accounting system (FAMOUS).

Motivation

1. Facilitation and support to the ongoing research work in the lab, providing flexibility over the usage of research funds and towards meeting the lab and research requirements due to time-lags in the arrival of funds of on-going research projects.
2. Recognition of research performance annually across the University, honouring of exceptional research through an Award, citation and funding.

Operational Mode

- The IoE Professional Development Fund (IPDF) and the Award amounts can be operated through FAMOUS.
- The total IPDF per faculty **cannot exceed Rs 6,00,000/-** in a calendar year
- The publications which are produced from the date of announcement of the IPDF must duly acknowledge “financial support to UoH-IoE by MHRD (F11/9/2019-U3(A))”.
- Here and throughout ‘annual’ shall mean calendar year (Jan-Dec). The period/year of assessment will be mentioned in the Call.

Note

- The scheme and its criteria are subjective to modifications from time to time depending upon the availability of funds. The faculty will be informed duly.
- The releases will be annual and claim can be placed when the circular is issued (subjected to release of funds).
- The nodal officers of your respective schools may be contacted for queries.
- All are required to give complete information in the claim form to avoid unnecessary delays.

Note: 1-11 are for publications where the faculty is the corresponding author (or eligible for waiver as provided under some important points about the scheme). and 12 is for publications where faculty is non-corresponding author. In case multiple faculty authors from UoH (some corresponding and some non-corresponding) claim a paper for IPDF, the following procedure will be followed to determine IPDF for each author:

(i) IPDF that a paper fetches as per clauses 1-11 is determined (let us say X)

(ii) IPDF that a paper fetches as per clause 12 is determined (let us say Y)

(iii) X-Y to be divided equally among all corresponding authors and Y to be divided equally among all non-corresponding authors provided the share of each corresponding author is at least equal to the share of each non-corresponding author. Wherever that is not possible, the X to be divided equally among all authors.

Explanation:

- a) The minimum requirement of 2 papers entitles the Faculty to the IPDF, but not the incentives.
- b) However, if a faculty member has two papers and one of them meets the requirements of 1b, 1c, 1d, 1e then that particular paper is eligible for an additional incentive, as per the table of incentives below, over and above the IPDF of Rs 50000 (making it 50,000 as basic incentive + the amount for ranked papers).
- c) Those who published only one paper but if the paper meets requirements in 1b, 1c, 1d or 1e in the table of incentives, s/he can claim the incentive for that paper. This is meant to incentivise publications in higher ranked journals.
- d) Every additional paper beyond the minimum requirement will be eligible for an incentive under **1a** in the table of incentives.
