The University invites applications for 5th year Financial Assistance @ Rs. 5,000/- p.m. for a maximum period of 12 months, from eligible Ph.D. scholars who availed Non-NET fellowship for initial four years. The guidelines notified vide Circular No. UH/DSW/F&S/5th year FA/2023/309, dated 11.09.2023 for 5th Year Financial Assistance are enclosed herewith for information and compliance

Eligibility:

- i. The student who availed of a Non-NET fellowship for the initial four years (i.e. from the semester Jan-June 2021 to semester July-Dec 2024).
- ii. The 5th-year Ph.D. scholars who complete 9th and 10th-semester registrations (semesters Jan June 2025 & July –Dec 2025) before the specified deadline (Inclusive of date with fine/penalty).
- iii. The parental income shall be less than two lakhs in the previous financial year.
- iv. The Doctoral Research Committee (DRC) is required to make a recommendation for the scholar for each semester (9th & 10th).
- v. The student who receives financial assistance, scholarship, or fellowship from other sources (State/Central) is not eligible.
- vi. Any disbursed 5th Year Financial Assistance amount shall be refunded to the University if a student withdraws or discontinues from the programme/course. The amount paid shall be treated as dues from the student.
- vii. The student shall apply through the proper channel, i.e., Supervisor/ Head/ Dean of the Academic Unit, after renewal of the 9th and 10th semesters within the due date for such registrations, with necessary enclosures, including a copy of SBI bank account details.
- viii. Any proven charge of misbehavior or misconduct towards fellow students & scholars, faculty, non-teaching personnel, or service providers on campus will result in disqualification for both application and continuation of 5th Year Financial Assistance. 5th Year Financial Assistance applicants must uphold a satisfactory academic trajectory throughout their course.
 - ix. Only scholars who registered for the Ph.D. program during the Jan-June 2025 semester are eligible to apply for 5th Year Financial Assistance during the July-Dec 2025 semester (10th Semester).

How to Apply:

Eligible Ph.D. scholars who meet the eligibility criteria should apply in the prescribed format (a copy is enclosed) along with the required documents. The application should be duly certified by the respective Supervisor, Head and Dean and submitted to the Fellowships & Scholarships Section (DSW Office) on or before 30th September 2025 (4:00 PM).

Incomplete application form and necessary required documents will not be processed for the sanction of the 5th year Financial Assistance. The Fellowships & Scholarships Section is not responsible for mistakes made by the scholars while filling & submit application form.

GUIDELINES FOR 5TH YEAR FINANCIAL ASSISTANCE

1. INTRODUCTION

The following guidelines outline the process for sanctioning Financial Assistance to 5th-year PhD Scholars who have availed of a Non-NET Fellowship for four years, at Rs. 5000/- per month for a maximum period of 12 months.

2. ELIGIBILITY

- i. The student who availed of a Non-NET fellowship for the initial four years.
- ii. The 5th-year Ph.D. scholars who complete 9th and 10th-semester registrations before the specified deadline (Inclusive of date with fine/penalty).
- iii. The parental income shall be less than two lakhs in the previous financial year.
- iv. The Doctoral Research Committee (DRC) is required to make a recommendation for the scholar for each semester (9th & 10th).
- v. The student who receives financial assistance, scholarship, or fellowship from other sources(State/Central) is not eligible.
- vi. Any disbursed 5th Year Financial Assistance amount shall be refunded to the University if a student withdraws or discontinues from the programme/course. The amount paid shall be treated as dues from the student.
- vii. The student shall apply through the proper channel, i.e., Supervisor/ Head/ Dean of the Academic Unit, after renewal of the 9th and 10th semesters within the due date for such registrations, with necessary enclosures, including a copy of SBI bank account details.
- viii. Any proven charge of misbehaviour or misconduct towards fellow students & scholars, faculty, non-teaching personnel, or service providers on campus will result in disqualification for both application and continuation of 5th Year Financial Assistance. 5th Year Financial Assistance applicants must uphold a satisfactory academic trajectory throughout their course.

3. APPLICATION PROCEDURE

Eligible 5th Year Scholars who meet the eligibility criteria should apply in the prescribed format (a copy is enclosed) along with the required documents. These documents should be duly certified and forwarded by the respective Supervisor, Head and Dean to the Fellowships & Scholarships Section before the notification's due date. A notification shall be issued after the completion of the last date (with fine) for semester registration of each Semester.

4. SELECTION PROCEDURE

As outlined below, 5th Year Financial Assistance will be sanctioned based on the following four components and their respective points on a 100-point scale.

The Income Certificate issued by the Tehsildar / Mandal Revenue Officer / equivalent Government Officer shall only be considered valid certificates for sanction of the 5th Year Financial Assistance.

II. Points for Backward Region / District shall be awarded as per the below table:

In the Aadhar Card/Nativity certificate, mention of the Backward District Name is essential to consider the above points.

5. ASSISTANCE & TENURE

- i. The 5th Year Financial Assistance shall be paid at Rs. 5,000/- per month for a maximum period of 12 months of the 5th Year PhD program or date of submission of PhD thesis or date of issue of No Dues or date of exit of the PhD program, whichever is earlier. Payment shall be released during the 10th Semester of the Ph.D. program, subject to the availability of funds.
- ii. Sanctions and payments are contingent upon the availability of funds within a given financial year.
- iii. Payments are regulated in the financial year structure rather than an academic year structure, allowing the University the option to distribute them in installments rather than semester-wise.
- iv. Before disbursing the 5th Year Financial Assistance, the University is authorized to adjust / deduct the amount against any pending mess dues of the scholar, duly obtaining confirmation from the Chief Warden's Office.

6. DOCUMENTS REQUIRED

Applicants must submit the following documents along with their application:

- i. A copy of semester registration for the 9th and 10th semesters.
- ii. A copy of the latest Caste Certificate (in the prescribed format) issued by the Tehsildar / Mandal Revenue Officer / equivalent Government Officer. OBC(non-creamy layer) students who fail to submit their caste certificate in the Govt. of India format shall be treated as "General".
- iii. A copy of the valid Income Certificate of the parent for the previous financial year duly issued by the Tehsildar / Mandal Revenue Officer / equivalent Government Officer.
- iv. A copy of the Aadhar Card (mentioning the Backward District Name) or Nativity Certificate for claiming the Backward Region / District.
- v. A copy of the Doctoral Research Committee (DRC) for the 9th and 10th Semester (s).
- vi. A Passbook copy of the SBI Savings Bank Account

7. SCRUTINY AND PROCESS

- i. The applications of eligible 5th Year PhD Scholars (who have availed of Non-NET Fellowship for four years) shall be certified by the concerned Supervisor, Head of the Department and Dean of the School to ensure that the scholar is eligible for 5th Year Financial Assistance as per the prescribed guidelines. The scholar should be registered for the current Semester and have active on-roll semester registration status. Subsequently, the scholar shall apply to the Fellowships & Scholarships Section with all necessary enclosures for scrutiny and further processing.
- ii. Upon receiving the applications, the Fellowships & Scholarships Section will verify the eligibility criteria and enclosed documents before accepting them. Subsequently, the applications will be submitted to the Centralized Screening Committee, constituted by the Competent Authority. The committee will assess and provide recommendations. Incomplete and non-eligible applications will not be recommended for the sanction of 5th Year Financial Assistance. The Centralized Screening Committee will ensure a fair and transparent process.
- iii. If more applications are received, a higher benchmark on a 100-point scale is applied by the committee to restrict the assistance within the availability of funds in a financial year.
- iv. Mere fulfilling the criteria may not have any right to get financial assistance.

8. CENTRAL SCREENING COMMITTEE

For this purpose, a Central Screening Committee, constituted by the Competent Authority, shall meticulously review all the applications and recommend a selected list for approval.
